to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said M. N. Fore, his heirs and assigns forever:

All those lots of land in Greenville County, State of South Carolina, in Gantt Township, near the City of Greenville, being shown as Lots 54, 90, and 93 on a plat of Brookwood, recorded in Plat Book "BB" at Page 27, and separately described as follows:

LOT 54: BEGINNING at an iron pin on the northern side of Harvard Drive 182.2 feet west from right angle turn of said drive at corner of Lot 53 and running thence with the line of said lot N. 2-15 E. 165 feet to a stake at corner of Lot 81; thence with the line of said lot N. 37-45 W. 100 feet to stake at corner of Lot 55; thence with the line of said lot S. 2-15 W. 165 feet to a stake on the northern side of Harvard Drive; thence with said drive S. 87-45 E. 100 feet to the beginning corner.

LOT 90: BEGINNING at a stake on the eastern side of Gantt Drive at corner of right angle turn of said street at corner of Lot 89 and running thence with the line of said lot N. 32-45 E. 163 feet to a stake in line of Lot 5; thence with the line of said lot N. 30-22 E. 103.4 feet to a stake at corner of Lot 91; thence with the line of said lot N. 87-58 W. 211 feet to a stake on Gantt Drive; thence with the eastern side of said drive S. 3-15 W. 100 feet to the beginning corner.

LOT 93: BEGINNING at a stake at the northwestern corner of right angle turn of Gantt Drive and running thence with the western side of said drive N. 3-15 E. 187 feet to stake; thence N. 37-30 W. 100 feet to stake at corner of Lot 94; thence with the line of said lot S. 3-15 W. 187.5 feet to a stake on Gantt Drive; thence with the northern side of Gantt Drive; S. 87-45 E. 100 feet to the beginning corner.

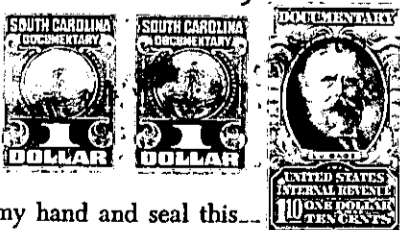
