

Know All Men by These Presents:

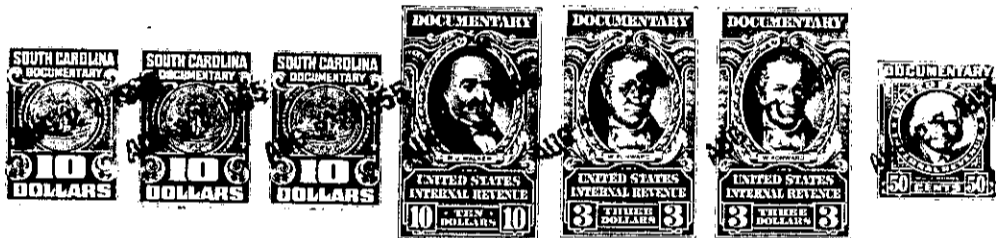
That I, Maude C. H. Wilson in the State aforesaid,
