to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Jack Earl Pittman and Dorothy Mull Pittman, their heirs and assigns:

All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, in the County of Greenville, State of S. C. on the North-western side of View Point Drive, being known and designated as Lot # 12, Block A of Hughes Heights Subdivision and being as shown on a plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book GG at pages 122 and 123. The within conveyed premises have according to said plat the following metes and bounds, courses and distances, to-wit:

BEGINNING at an iron pin on the Northwestern side of View Point Drive at the joint front corner of Lots # 12 and 13, Block A and running thence along the common line of said lots N. 31-40 W. 177.8 feet to an iron pin; thence along the common line of Lots # 7 and 12 S. 39-42 W. 99.6 feet to an iron pin, the joint rear corner of Lots # 11 and 12; thence along the common line of said last mentioned lots S. 39-28 E. 145.2 feet to an iron pin on the Northwestern side of View Point Drive; thence along the Northwestern side of View Point Drive N. 59-56 E. 75 feet to an iron pin, the beginning corner.

The above described property is conveyed subject to restrictions applicable to Hughes Heights Subdivision recorded in the R.M.C. Office for Greenville County in Deed Book 526 at page 462.

The subject premises constitute a portion of the real estate owned by T. T. Hughes at the time of his death. The said T.T. Hughes died testate on July 24, 1951, his will being of record in the office of the Probate Court for Greenville County in Apartment 603, file 10.
