to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

F. R. COX, F. R. COBB and W. G. GRANGER, TRUSTEES OF DUNEAN METHODIST CHURCH, their successors and assigns,

ALL that certain piece, parcel or lot of land in the County of Greenville, State of South Carolina, in Greenville Township, being known and designated as LOT NO. 22 on BIRCHWOOD DRIVE as shown on plat of Subdivision known as Kirkwood Heights according to Survey made by Pickell & Pickell, Engrs. in October 1954 and recorded in the RMC Office for Greenville County in Plat Book "EE", at pages 110 and 111 and having the following metes and bounds:

BEGINNING at an iron pin at the joint front corner of Lots 22 and 23 and running thence along the joint line of said lots, South 17-56 East 150 feet to an iron pin; running thence North 72-04 East 80 feet to an iron pin; running thence North 17-56 West 150 feet to an iron pin on Birchwood Drive; running thence along Birchwood Drive, South 72-04 West 80 feet to the point of beginning.

This property is sold subject to the restrictive covenants, easements and rights-of-way recorded against said Subdivision in the RMC Office for Greenville County in Deed Book 519, at page 439 and also shown on the plat of Kirkwood Heights recorded in Plat Book "EE", at pages 110 and 111, RMC Office for Greenville County. IN TRUST, that such premises shall be held, kept, maintained, and disposed of, as a place of residence for the use and occupancy of the preachers of The Methodist Church, who may from time to time be appointed in said place; subject to the usage and Discipline of said Church, as from time to time authorized and declared by the General Conference of said Church and by the annual Conference within whose bounds the said premises are situated.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

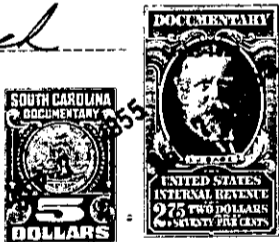
TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their successors and Assigns forever.
