Know All Men by These Presents:

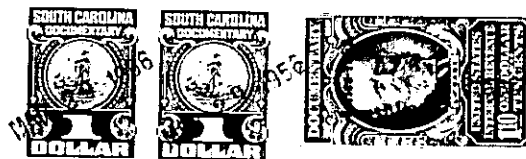
That I, Willie Mae Gosnell Parham, in consideration of the sum of One Thousand (\$1,000.00) in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Homer Franklin Burns all my one-half undivided interest in and to the following lot:

All that certain lot or parcel of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as Lot No. 18 on plat of property of C. E. Briscoe made by C. M. Furman, Jr., engineer, in May 1923 which is of record in the R. M. C. Office for Greenville County in Plat Book F at page 166, which lot is more particularly described as follows:

BEGINNING at a point on Gentry Street, said point being the joint corners of lots 18 and 19 and running thence along the joint line of lots 18 and 19 S. 55-30 W. 153.39 feet to a point, which point is the joint corners of Lots 8, 9, 18 and 19; thence running along the common boundary of lots 9 and 18 N. 34-30 E. 50 feet to a point which is the joint corner of lots 9 and 18; thence running in a line parallel with the common boundary of lots 18 and 19 N. 55-30 W. 153.47 feet to a point on Gentry Street; thence along Gentry Street S. 34-53 E. 50 feet to the beginning corner.

This being a part of the land conveyed to me and to Homer Franklin Burns by deed dated October 18, 1955, which is of record in the R. M. C. Office for Greenville County, South Carolina, in Deed Book 538 at page 153.
