in consideration of the sum of Seven Hundred Sixty and No/100 - - - - - in the State aforesaid, (\$760.00) DOLLARS,

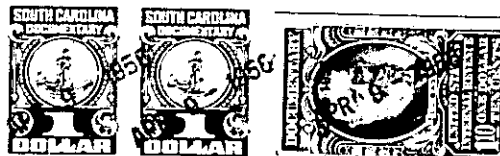
