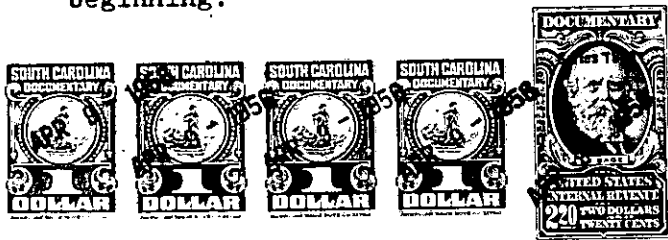
Know All Men by These Presents:

ALL That certain piece, parcel or lot of land in Greenville County, State of South Carolina, being known and designated as Lot No. 11 on plat of Bruce Heights, prepared by C. C. Jones, Engineer, recorded in the Office of the R.M.C. for Greenville County in Plat Book ____, Page ____, and having according to said plat the following metes and bounds, to-wit:

BEGINNING At an iron pin on the East side of Nora Drive at the joint front corner of Lots 10 and 11, and running thence along the joint line of said lots, N. 79-10 E. 190 feet to an iron pin, joint rear corner of Lots 10 and 11; thence turning and running along the rear line of Lot No. 11, S. 1-50 E. 113.4 feet to an iron pin, joint rear corner of Lots 11 and 12; thence turning and running along the joint line of said lots, S. 86-26 W. 175 feet to an iron pin on the East side of Nora Drive, joint front corner of Lots 11 and 12; thence turning and running along the East side of Nora Drive, N. 7-13 W. 19.3 feet to an iron pin; thence N. 10-50 W. 70.7 feet to an iron pin, the point of beginning.
