James L. Mercer, his heirs and assigns forever:

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the southwesterly side of Cool Brook Drive, near the City of Greenville, S. C., being shown as Lot No. 56 on the plat of Belmont Heights as recorded in the RMC Office for Greenville County, S. C. in Plat Book GG, pages 54-55, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwesterly side of Cool Brook Drive at a point 310 feet south-east of the southerly corner of the intersection of Cool Brook Drive and Melvin Drive, said pin being the joint front corner of Lots Nos. 55 and 56, and running thence along the southwesterly side of Cool Brook Drive S 24-34 E 70 feet to an iron pin, joint front corner of Lots Nos. 56 and 57; thence along the joint line of said lots S 64-26 W 155 feet to an iron pin in the center of a branch; thence up the branch as the line, a traverse line being N 26-00 W 70 feet to an iron pin, joint rear corner of Lots Nos. 55 and 56; thence along the joint line of said Lots N 64-26 E 156 feet to the point of beginning.
