BEGINNING at a stake at the Northwestern corner of Gallivan Avenue and Bennett Street, and running thence with the Northern side of Gallivan Avenue, N. 71-43 W. 71 feet to a stake at the corner of lot 59; thence with the line of said lot, N. 19-17 E. 170 feet to a stake on a 20-foot alley; thence with the Southern side of said alley, S. 71-43 E. 71 feet to a stake on Bennett Street; thence with the Western side of Bennett Street, S. 19-17 W. 170 feet to the beginning corner.
