ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, being known and designated as lot 50 of a subdivision known as Section "B" of Englewood Estates, as shown by a plat thereof dated November, 1951, recorded in R. M. C. Office for Greenville County in Plat Book "BB" at page 11.

BEGINNING at an iron pin on Engle wood Drive and running S. 87-30 E. 75 feet to an iron pin joint front corner of lots 50 and 51; thence along the line of lots 50 and 51 N. 2-30 E. 150 feet to an iron pin, joint rear corner of lots 50 and 51; thence N. 87-30 W. to an iron pin, joint rear corner of lots 50 and 1; thence along the line of lots 50, 1 and 2, S. 2-30 W. 150 feet to an iron pin on Englewood Drive, the point of beginning.

Restrictions:

No residence is to cost less than \$8500.00; no residence shall be erected on said lot nearer than 50 feet to the front line; and no residence shall be built on any lot unless said lot have 50 feet or more frontage; and no outside toilets are permitted and sewage must be disposed of by approved septic tanks.

GRANTEE is to pay taxes for the year1956.
