

All that piece, parcel or lot of land situate, lying and being in Gantt Township, Greenville County, State of South Carolina and being known and designated as Revised Lot lo. 82 of Pecan Terrace according to a revised plat of a portion thereof prepared by Piedmont Engineering Service and recorded in the R.M.C. Office for Greenville County in Plat Book II at page 65, and having the following metes and bounds, to-wit:

BEGIN.ING at an iron pin on the eastern side of Twin Springs Drive, joint front corner of Lots Nos. 83 and 82 and running thence along said Drive N. 30-25 W. 70.2 feet to an iron pin, joint front corner of Lots Nos. 81 and 82; thence along the joint side line of said lots N. 64-34 E. 156 feet to an iron pin, joint rear corner of said lots; thence S. 25-26 E. 64.0 feet to an iron pin, joint rear corner of Lots Nos. 82 and 83; thence along the joint side line of said lots S. 62-18 W. 150 feet to an iron pin, the point of beginning.
