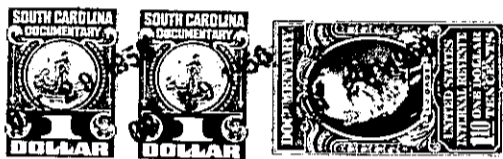
Thad C. Boroughs, Jr., his heirs and assigns forever:

All that certain piece, parcel or lot of land lying and being on the southerly side of Heathwood Drive, near the Town of Taylors, S. C. in Plat Book KK, page 35, and having according to said plat the following metes and bounds, to-wit:
