All that piece, parcel or lot of land, with the improvements thereon situate, lying and being in the State and County aforesaid, near the City of Greenville, being known and designated as Lot 30 on a plat of Sylvan Hills by Piedmont Engineering Service dated June 1918, recorded in the RMC Office for Greenville County, S. C. in Plat Book S at page 103 and having, according to said plat, the following courses and distances, to-wit:

BEGINNING at an iron pin on the Western side of Morningside Drive at the joint front corner of Lots 29 and 30 and running thence with the joint line of said lots, S. 85-28 W. 150 feet to an iron pin on the Eastern side of the Old Augusta Road; thence with the Eastern side of Old Augusta Road S. 4-32 E. 70 feet to an iron pin, joint rear corner of Lots 30 and 31; thence with the joint line of said lots, N. 85-28 E. 150 feet to an iron pin on the Western side of Morningside Drive; thence with the Western side of Morningside Drive, N. 4-32 W. 70 feet to the beginning corner.

The foregoing description is also in accordance with a more recent plat entitled "Property of James Austin Evatt, Jr." by R. K. Campbell, R. L. S., dated November 17, 1956, which plat is also adopted by reference.
