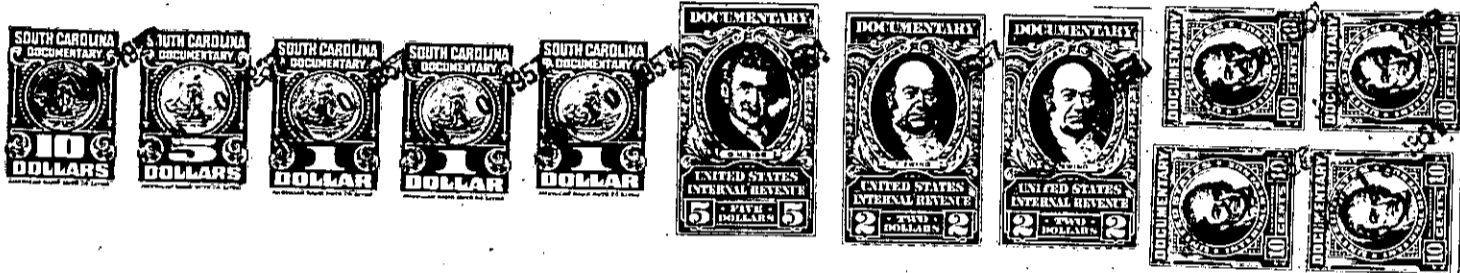

Smith, in the State aforesaid, in consideration of the sum of Eight Thousand Seven Hundred and Fifty (\$8,750.00) - - DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Jessie Tilmon Grice, Jr., and his heirs and assigns forever:

All of that parcel or lot of land in Chick Springs Township of Greenville County, South Carolina, located near Pleasant Grove Baptist Church and south therefrom, lying on the west side of a new street and near the old Greenville-Spartanburg Road, being all of Lot No. 29 on a plat of property made for the J.M. Mattox Estate by H.S. Brockman, Surveyor, dated November 6, 1952, amended February 25, 1956, and recorded in the R.M.C. Office for Greenville County in Plat Book JJ, page 127, and having the following courses and distances:

BEGINNING on a stake on the western margin of said new street, joint corner of Lots Nos. 29 and 31, and runs thence with the common line of these lots, N. 41.20 W. 200 feet to a stake; thence N. 48.40 E. 100 feet to a stake; thence with the common line of Lots Nos. 27 and 28, S. 41.20 E. 200 feet to a stake on the western side of said new street; thence therewith N. 48.40 E. 100 feet to the beginning corner.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
