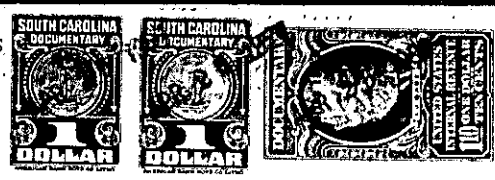

Know All Men by These Presents:

That I, Wesley Ray Daniels, in the State aforesaid,  
in consideration of the sum of One Thousand and no/100 (\$1,000.00) DOLLARS,  
and assumption of the mortgage set forth below,  
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Joseph C. Aldridge, his heirs and assigns forever:

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the southwesterly side of Westbrook Lane, near the City of Greenville, S. C., being shown as Lot No. 11, Block C, on the plat of Brookforest as recorded in the RMC Office for Greenville County, S. C. in Plat Book BB, page 41, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwesterly side of Westbrook Lane at a point 595.5 feet northwest of the westerly corner of the intersection of Westbrook Lane and Woodmont Circle, said pin being the joint front corner of Lots Nos. 10 and 11, Block C, and running thence along the joint line of said lots S 55-42 W 175 feet to an iron pin, corner of Lot No. 21; thence along the line with Lot No. 21 N 34-18 W 70 feet to an iron pin, joint rear corner of Lots Nos. 11 and 12; thence along the joint line of Lots Nos. 11 and 12 N 55-42 E 175 feet to an iron pin on the southwesterly side of Westbrook Lane; thence along the southwesterly side of Westbrook Lane S 34-18 E 70 feet to the point of beginning.
