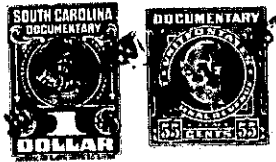

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said KENNETH STROUP OWENS, his heirs and assigns:

All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 14, North Acres, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "EE", pages 12 and 13, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the curve of Neal Circle at the joint front corner of Lots 13 and 14, and running thence S. 80-06 E. 181.7 feet to an iron pin; thence S. 13-05 E. 72 feet to an iron pin; thence S. 79-10 W. 154.8 feet to an iron pin, joint rear corner Lots 14 and 15; thence N. 37-24 W. 111.2 feet to an iron pin on Neal Circle; thence around the curve of Neal Circle, the chord of which is N. 51-26 E. 25.7 feet and N. 10-17 E. 25.8 feet to an iron pin, the point of beginning.

Grantee to pay 1957 taxes.
