All that certain piece, percel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and within the corporate limits of the City of Greenville, being known and designated as lot No. 20 of a subdivision known as Stone Lake Heights, Section # 1, as shown on plat thereof prepared by Piedmont Engineering Service, June 1952, and recorded in the R.M.C. Office for Greenville County in Plat Book BB, at Page 133, and having, according to said plat, the following metes and bounds, to-wit:

BECIMNING at an iron pin on the Eastern edge of Chick Springs Road, the joint front corners of lots #19 and 20, and running thence along the joint line of said lots, S. 81-28 E. 145.2 feet to an iron pin at the joint rear corner of lots # 18 and 20A; thence along the rear line of lot # 20A, N. 10-07 E. 137.3 feet to aniron pin, the joint rear corner of lots # 20A and 22; thence along the line of lot # 21, N. 74-05 W. 145.4 feet to an iron pin on the eastern edge of the Chick Springs Road; thence along the Eastern edge of the Chick Springs Road, following the curvature thereof, the chord of which is approximately S. 23 W. 50 feet to an iron pin: thence continuing along the eastern edge of the Chick Springs Road, S. 4-17 W. 108 feet to the beginning corner.
