KNOW ALL MEN BY THESE PRESENTS That More, Inc.

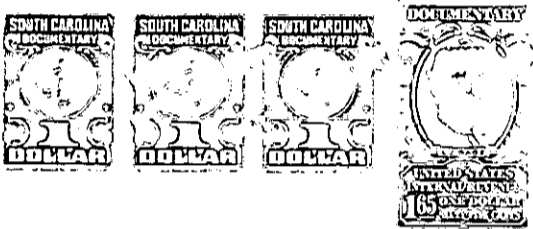

B. Willis, Jr., his heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being on the easterly side of Bear Grass Drive, near the City of Greenville, S. C., and being shown as Lot No. 43 on the plat of Billmore as recorded in the REC Office for Greenville County, S. C. in Plat Book Y, page 147, and having according to said plat the following areas and bounds, to-wit:

BEGINNING at a concrete monument, joint front corner of Lots 42 and 43, and running thence along the common line of said lots S 75-14 E 100.00 feet to an iron pin; thence N 24-40 E 70.15 feet to an iron pin, joint rear corner of lots 43 and 44; thence along the common line of said lots N 75-14 W 201.00 feet to an iron pin on the easterly side of Bear Grass Drive; thence along the easterly side of said Drive S 14-40 W 75 feet to a concrete monument, the point of beginning.
