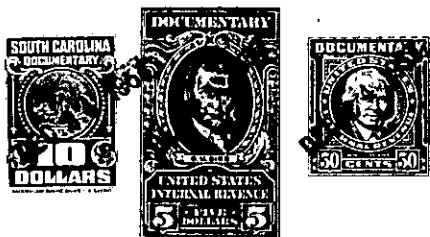
That we, Pearline W. Gilstrap and R.C. Sutherland in the State aforesaid, in consideration of the sum of One and no/100 DOLLARS,

Rufus Sutherland, his heirs and assigns forever:

All of that lot of land in the County of Greenville, State of South Carolina, in the City of Greenville, on the northeast side of Keith Drive, approximately 800 feet northwest of the intersection of Lowndes Hill Road, and having, according to a plat entitled "Property of Marshal F. Vaughn" made by W. J. Riddle and recorded in the R.M.C. Office for Greenville County in plat book 00 at page 63, the following mates and bounds, to-wit:
