ALL that certain lot of land in Greenville Township, Greenville County, State of South Carolina, about 2 miles from the City of Greenville, near the Pendleton Road, being known and designated as Lot No. 30 and a 10-foot strip off of Lot No. 28 on plat of Hoke Subdivision, recorded in the R. M. C. Office for Greenville County in Plat Book C, Page 54, and having, the following metes and bounds:
