

Sidney and T. J. Garrett, their heirs and assigns forever:

All that lot of land in Greenville County, State of South Carolina, on the Southeastern side of Dakota Avenue, (formerly Parkins Mill Road), near the City of Greenville, being shown as Lot No. 6 of Block H, Section 4, on Plat of East Highlands Estates, made by Dalton and Neves, Engineers, January, 1941, recorded in Plat Book K at Pages 78, 79 and 80, and having, according to said Plat the following metes and bounds, to-wit:

Beginning at an iron pin on the Southeastern side of Dakota Avenue at the joint front corner of Lots Nos. 5 and 6 of Block H, and running thence with the line of Lot No. 5, S. 58-37 E. 198.7 feet to an iron pin on the Northwestern side of a 10 foot strip of land reserved for utilities; thence with the Northwestern edge of the strip of land reserved for utilities, S. 34-13 W. 66.1 feet to an iron pin; thence with the line of Lot No. 7, N. 58-37 W. 195.4 feet to an iron pin on Dakota Avenue; thence with the Southeastern side of Dakota Avenue, N. 31-23 E. 66 feet to the beginning corner.
