to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

B. Kate Moore, her Heirs and Assigns forever;

All that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville and within the corporate limits of the City of Greenville, being known and designated as Lot Number 79 of a subdivision known as Stone Lake Heights, Section Number 2, as shown on a plat thereof prepared by Piedmont Engineering Service, July 15, 1953, and recorded in the R. M. C. Office for Greenville County in Plat Book W at Page 87, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwestern side of Lake Forest Drive, the joint front corner of Lots 79 and 80, and running thence along the joint line of said lots, N. 50-41 W. 158.6 feet to an iron pin on the rear line of Lot 84; thence along the rear line of that lot, N. 25-06 E. 46.5 feet to an iron pin at the joint rear corner of Lots 84 and 85; thence along the rear line of Lot 85, N. 39-19 E. 55 feet to an iron pin at the rear corner of Lot 78; thence along the line of that lot, S. 50-41 E. 170 feet to an iron pin on the Northwestern side of Lake Forest Drive; thence along the Northwestern side of Lake Forest Drive, S. 39-19 W. 100 feet to the beginning corner.

This conveyance is subject to restrictions and protective covenants recorded in the R.M.C. Office for Greenville County in Deed Vol. 483 at Page 355, and is also subject to certain easements or rights of way for the installation and maintenance of public utilities, which easements also appear of record in said R.M.C. Office.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

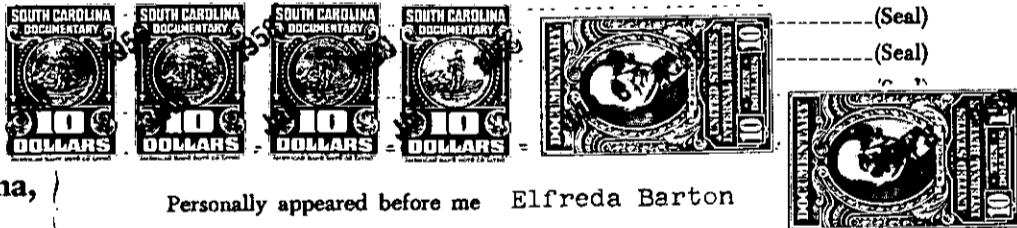
TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.
