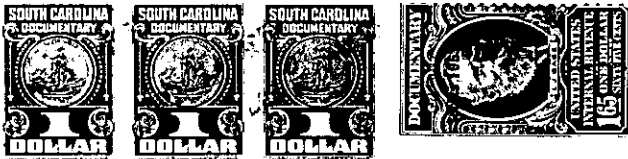
Know All Men by These Presents:

P. Holloway, his heirs and assigns:

ALL that lot of land in Greenville County, South Carolina known and designated as Lot #50 of a subdivision known as Grand-View as shown by a plat thereof made by Woodward Engineering Company, March, 1957 and recorded in the Greenville County R. M. C. Office in Plat Book "KK", at page 93, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the northern side of Crestmore Drive at the joint front corner of Lots #49 and #50 and running thence with the northern side of Crestmore Drive, N. 72-50 E., 60 feet to a pin at the corner of Lot #51; thence with the line of Lot #51, N. 15-43 W., 158.2 feet to a pin in the subdivision property line; thence with the subdivision property line, S. 74-17 W., 59.9 feet to a pin at the rear corner of Lot #49; thence with the line of Lot #49, S. 15-43 E., 159.8 feet to the point of beginning.

This is the same property conveyed to me by Arrowood and Burger and by deed recorded in Vol. 573, at page 314 and to them by Eliza T. Looper by deed in Vol. 573, at page 311. This lot is subject to restrictions in Vol. 573, at page 415 and Vol. 574, at page 93.
