That I, R. M. GAFFNEY, as Trustee, under Trust Agreement entered into December 17, 1957, between R. M. Gaffney as Trustee, and S & M Real Estate Company, Inc., et al in the State aforesaid, in consideration of the sum of One Thousand One Hundred and No/100----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. HENRY SITTON, his heirs and assigns, forever:

ALL that lot of land situate on the Southeast side of Harbor Drive, near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 53 on Plat of Lake Harbor, made by Dalton & Neves, Engineers; May, 1958, recorded in the RMC Office for Greenville County, S. C., in Plat Book "MM", at page 15, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southeast side of Harbor Drive, at joint front corner of Lots 18 and 53, and running thence with the line of Lot 18, S. 50-41 E., 193 feet to an iron pin; thence continuing S. 50-41 E., to a point in the high water mark of Saluda Lake; thence along the high water mark of Saluda Lake (the traverse lines being S. 2-46 E., 100 feet, and S. 29-33 W., 40 feet) to a point at the rear corner of Lots 17 and 53; thence N. 39-41 W., 275.1 feet, more or less, to an iron pin on the Southeast side of Harbor Drive; thence with the curve of Harbor Drive (the chord being N. 34-34 E., 55 feet) to the beginning corner.

THIS is a portion of the property conveyed to the Grantor herein by deed of Harold R. Turner, Jr., dated December 17, 1957, recorded in the RMC Office for Greenville County, S. C., in Deed Book 590, page 40, and this deed is made pursuant to the authority vested in me under said deed.

GRANTEE to pay 1958 taxes.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
