Know All Men by These Presents:

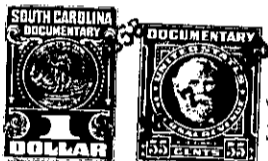
That I, Hovey J. Campbell in the State aforesaid, in consideration of the sum of Three Hundred & No/100 (\$300.00) DOLLARS,

By Allen Littlefield to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Allen Littlefield all that piece, parcel or lot of land in Glassy Mountain Township, Greenville County, South Carolina on branch waters of Vaughan's Creek, Adjoining land of Ballew, Blackwell and others:

Beginning on a stone in Sarah Blackwell's line and running South 88 degrees West 493 feet to a chestnut oak, 3X; thence North 21 degrees West 890 feet to a chestnut; thence near Southeast 828 feet to a stone, Sarah Blackwell's corner, 3X, the beginning corner, containing 19 acres, more or less, and being the same conveyed by Oscar Blackwell to Delora McCurry Ballew by deed recorded in Book L Page 661 in Office of R.M.C. for Greenville County.

There is excepted from the above described tract of land a portion conveyed to Ed Camp, which portion contains 10 acres, and the remaining portion is all that is intended to be conveyed in this deed.
