

ALL that lot of land located on the eastern side of Flora Avenue in Greenville County, South Carolina, being a part of Lot #68, Map #2 of Camilla Park, according to a plat recorded in the Greenville County R. M. C. Office in Plat Book "M", at page 85, and having, according to said plat, the following metes and bounds:  BEGINNING at an iron pin on the eastern side of Flora Avenue, which pin is a distance of 351 feet in a northeasterly direction to an iron pin in the intersection of Flora Avenue and Daniel Avenue; and running thence S. 71-41 E., 304 feet to an iron pin, thence N. 12-04 E., 84.3 feet to an iron pin at the rear corner of Lot #67; thence with the joint line, N. 77-32 W., 278 feet to an iron pin on Flora Avenue; thence along Flora Avenue, S. 35-38 W., 60 feet to the beginning corner.
