All that piece, parcel or lot of land, situate, lying and being on the Northern side of Gilreath Street near the City of Greenville, in the County of Greenville, State of South Carolina, and is a part of the Hammett land and known and designated as Lot No. 8 on an unrecorded plat of L. O. Patterson, and according to said plat having the following metes and bounds, to-wit:
