to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ralph McDonald, his heirs and assigns, forever:

All that certain piece, parcel or lot of land lying and being in Austin Township, Greenville County, State of South Carolina, located on the South side of Morgan Circle in the Subdivision known as Roland Heights, being shown as Lot No. 41 in said subdivision, Plat thereof made by W. J. Riddle, Surveyor, in July 1950, and recorded in Plat Book S, at page 34, in the Greenville County R. M. C. Office, and being more fully described as follows:
