to the grantor(x) in hand paid at and before the sealing of these presents by the grantee(x) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto

JAMES A. HAYES, his Heirs and Assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Butler Township, being known and designated as Lot No. 7, as shown on plat of property of Morningside, as made by Dalton & Neves, Engineers, in December, 1952, which plat is of record in the R. M. C. Office for said County and State in Plat Book EE, at pages 2 and 3, reference to which plat is hereby made, said lot of land being described by metes and bounds, as follows; to-wit:

BEGINNING at an iron pin on the Northeastern side of Spring Valley Road as shown on said plat at the corner common to Lots 7 and 8, and running thence N. 42-58 W. along said Spring Valley Road, 88.6 feet to an iron pin; thence on an arc N. 1-22 E. 35.3 feet to an iron pin on High Point Street; thence along High Point Street N. 46-02 E. 163.9 feet to an iron pin common to Lot 16; thence along the dividing line of Lots 7 and 16 S. 42-20 E. 119.0 feet to an iron pin common to Lot 8; thence along the dividing line of Lots 7 and 8 S. 47-40 W. 187.5 feet to the place of beginning.

This property is subject to the restrictions and reservations set out in an instrument of writing dated January 20, 1953, and recorded in the R.M.C. Office for said County and State in Deed Book 470 at page 369, reference to which is hereby expressly made as a part of this conveyance, and is subject to the following additional restriction: "All tanks, barrels and containers for fuel oil shall be placed below the surface of the ground or concealed.

This is the same property conveyed to the grantor herein and Furman C. Smith by deed of Lide L. Richbourg and Lila M. Richbourg dated September 5, 1955, and recorded in the R.M.C.Office for Greenville County in Deed Book 534, at page 84, and by deed of Furman C. Smith dated September 30, 1958, conveying his one-half interest in said lot to the grantor herein, which deed is to be recorded herewith.
