

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on the East side of Pettigru Street in the City of Greenville, being Lot No. 19 shown on a plat made by W. D. Neves, dated November 1, 1921, and is part of the subdivision made by the said Neves for H. H. Griffin, and having the following metes and bounds, to-wit:

 Beginning at the northeast intersection of said Pettigru Street and Whitsett Street and running thence N. 16 E. 50 feet; thence N. 82-37 E. 77.7 feet; thence S. 21 W. 47 feet to Whitsett Street; thence along Whitsett Street S. 77-35 W. 95.6 feet to the beginning corner. It is understood and agreed that the warranty in this conveyance does not apply to any claim that the building on said lot encroaches upon the street.

 This being the same lot of land conveyed to me as Mrs. W. E. Gray, W. E. Gray being my late husband, by deed of Martha Stewart Scott on March 18, 1943, of record in the Office of the R. M. C. for Greenville County, S. C., in Deed Book 252, Page 83.

Also all that other piece, parcel or lot of land lying, being and situate in the City of Greenville, Greenville Township, State of South Carolina, and being more particularlarly described as follows: Beginning at a stake on an alley on the West side of Markley Street 153.5 feet South of the Southwest corner of Markley Street and Pendle ton Street, and running thence with Markley Street, N. 18-55 W. 48 feet to an iron pin; thence S. 74 W. 104.7 feet to an iron pin; thence S. 17-20 E. 48 feet to corner of alley; thence along said alley N. 75 E. 106 feet to the beginning corner. The alley herein referred to shall forever remain open for the joint use of adjoining property owners on the North and South thereof. This being the identical property conveyed to my late husband, the said W. E. Gray, by deed of Eleanor Jordan Land, November 29, 1954, of record in said R. M. C. Office in Deed Book 513, Page 405.
