to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Eleanor Lee Smith Rodgers, her heirs and assigns forever

All those certain pieces, parcels or lots of land, situate, lying and being in Butler Township, County of Greenville, State of South Carolina, as shown on plat of property of N. Victor Smith prepared by H. S. Brockman, R. S., 4 September, 1958, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin in County Road, joint corner of property herein conveyed and property of Yearwood, and running thence along the center of said road, S. 5-00 W., 148.5 feet to an iron pin; running thence S. 56-34 W., 709 feet to an iron pin; running thence N. 57-24 W., 157 feet to an old stone; N. 12-30 E., 264 feet to a point; thence N. 47-47 E., 262.5 feet to an old stone; thence S. 51-45 E., 199 feet to an old stone; thence N. 68-54 E., 244.5 feet to an old stone; thence S. 57-13 E., 69.5 feet to the point of BEGINNING. The said tract containing 5.20 acres, and being bounded by the lands of the grantee, Yearwood, County Road, Jane L. Williams, and Griffin Estate, and being a portion of the property conveyed to the grantor by deed recorded in the R. M. C. Office for Greenville County in Deed Book 576, Page 511, and corrected at Book 578, Page 507.

ALSO that certain right-of-way being eighteen (18) feet in width, and being along the Southerly line of Grantor and Griffin Estate, and running from the said County Road to the property herein conveyed to the grantee, a distance of 422 feet, said right-of-way being for road purposes, egress and ingress.

This being the identical piece, parcel or lot of land conveyed to the grantor by deed of James Leonard Williams dated the 9th day of September, 1958, said deed of record in the office of the R. M. C., County and State aforesaid, and recorded in book 606, at Page 7.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and her Heirs and Assigns forever.
