

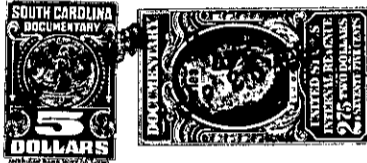

sum of Two Thousand One Hundred and No/100 (\$2,100.00)----- dollars,
to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt
whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and
release unto Mills Hughey:

All that parcel or lot of land lying and being in the County of Greenville,
State of South Carolina, being designated as Lot No. 28 as shown on Plat No.
Three, Cherokee Forest, prepared by J. Mac Richardson, R. L. S., in
January, 1959, and recorded in the R. M. C. Office for Greenville County,
South Carolina, in Plat Book QQ at pages 36 and 37, and having, according to
said plat, the following metes and bounds:

BEGINNING at an iron pin on the Eastern side of Vicki Circle, the joint front
corner of Lots Nos. 27 and 28, and running thence N. 80-00 E. 232.7 feet to
an iron pin; thence S. 9-42 E. 100 feet to an iron pin; thence S. 80-00 W. 232
feet to an iron pin on the Eastern side of Vicki Circle; thence with the
Eastern side of Vicki Circle N. 10-00 W. 100 feet to an iron pin, the point
of beginning.

The foregoing lot is a portion of that conveyed to Wilkins Norwood & Company,

in the R. M. C. Office for Greenville County, South Carolina.
