LOUIS COWARD CONSTRUCTION COMPANY, INC.

All that parcel or lot of land lying and being in the County of Greenville, State of South Carolina, being designated as Lot No. 14 as shown on Plat No. Three, Cherokee Forest, prepared by J. Mac Richardson, R. L. S., in January, 1959, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book QQ at pages 36 and 37, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Vicki Circle, the joint front corner of Lot No. 13 and 14 and running thence along the curve of Vicki Circle on its Northern side N. 50-37 E. 45.6 feet to an iron pin on Vicki Circle; thence continuing with Vicki Circle N. 70-32 E. 46.3 feet to an iron pin on Vicki Circle; thence turning and running N. 7-06 E. 203.7 feet; thence N. 85-29 W. 170 feet to an iron pin; thence S. 14-07 E. 268 feet to an iron pin on Vicki Circle, the point of beginning.
