CHARTER BY THE SECRETARY OF STATE

WHEREAS,

N. Q. CLINE and DON S. EDENS.

did on the 24th day of September, 19 59, file with the Secretary of State a written Declaration, signed by themselves, setting forth:

FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is THE NUT & BOLT HOUSE

THIRD: That the principal place of business is 606 Buncombe Street, GREENVILLE, S. C.

FOURTH: That the general nature of the business which it is proposed to do is the retailing and wholesaling of nuts, bolts, cap screws, washers, rivets and all types of fasteners and to do any and all other things generally done in a business of this type; to buy and sell real estate.

FIFTH: That the amount of the capital stock is Fifteen Thousand (\$15,000.00)----- Dollars payable \$3,000.00 paid in; \$12,000.00 subscribed

SIXTH: That the number of shares into which the capital stock is divided is One Hundred Fifty (150) of the par value of One Hundred (\$100.00)----- Dollars.

SEVENTH: That, after due notice, a meeting of the subscribers was held on the 19th day of September, 19 59, at which a majority of all stock in value being present in person or by proxy, the following were elected directors: N. Q. Cline and Don S. Edens

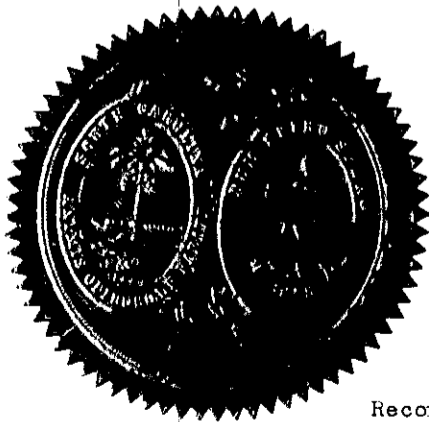
EIGHTH: That subsequently there was elected as President, N. Q. Cline ; as Vice-President, Don S. Edens ; as Secretary, Don S. Edens ; as Treasurer, N. Q. Cline

NINTH: That all requirements of Title 12, Article 1, Chapter 2, Code of Laws of South Carolina, 1952, and all amendments thereto have been duly and fully complied with, 50 per cent. of the aggregate amount of the capital stock having been subscribed by bona fide subscribers, 20 per cent. of the capital stock subscribed having been paid to the Treasurer, and three days' public notice of the intention to file this Declaration with the Secretary of State having been given in The Greenville Piedmont a newspaper published in the County of Greenville

NOW, THEREFORE, I, O. FRANK THORNTON, Secretary of State, by virtue of the authority in me vested by the aforesaid Code and Acts amendatory thereto, do hereby certify that the said Company has been fully organized according to the laws of South Carolina, under the name and for the purposes indicated in their written declaration, and that they are fully authorized to commence business under their charter; and I do hereby direct that a copy of this certificate be filed and recorded in the office of the Register of Mesne Conveyance or Clerk of Court in each county where such Corporation shall have a business office.

GIVEN under my hand and the seal of the State, at Columbia, this 24th day of September in the year of our Lord one thousand nine hundred and fifty-nine and in the one hundred and eighty-third year of the Independence of the United States of America.
