Hal D. Carter and Susette Carter, their heirs and assigns forever,

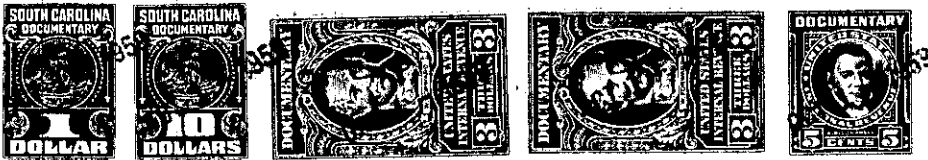
