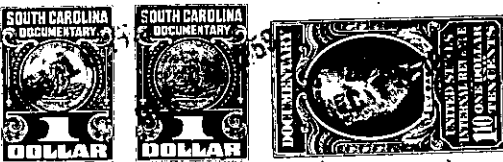
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said ROBERT E. JOHNSON, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina, near Mauldin, and being known and designated as Lot Number 61 of a subdivision known as Glendale, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book GG at Pages 32-33, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northern side of Fairfield Drive at the joint front corner of Lots 60 and 61 and running thence N 12-59 W 217.9 feet to a point at the joint rear corner of Lots 60 and 61; thence N 51-43 E 92.2 feet to a point; thence S 86-52E 17.3 feet to a point at the joint rear corner of Lots 61 and 62; thence S 12-59 E 252.5 feet to a point on the Northern side of Fairfield Drive at the joint front corner of Lots 61 and 62; thence with the Northern side of Fairfield Drive S 77-01 W 100 feet to the point of beginning.

THIS deed is executed subject to existing and recorded restrictions and rights-of-way.
