All that certain piece, parcel or lot of land situate, lying and being on the Western side of Scarlett Street (formerly known as Forest Green Road) near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 218 as shown on a plat of Sherwood Forest, prepared by Dalton & Neves, Engineers, August, 1951, revised through June, 1953, recorded in the R.M.C.
