Know All Men by These Presents:

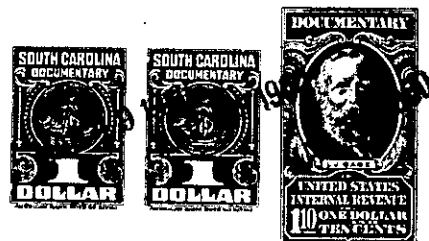
That I, J. Frank Williams, in the State aforesaid,
