HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said Mary H. Justice and H. H. Justice, Jr.

All of that lot of land, with the improvements thereon, situate in the Town of Mauldin, State of South Carolina, on the corner of Whatley Circle and Woodland Drive being known and designated as lot No. 10 on plat of Leake, Garrett and others, made by Johes & Sutherland, Engineers, dated February 27, 1958 and being more fully described in accordance with said plat, to-wit:
