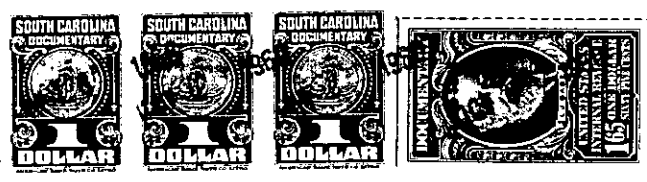
That I, WILLIAM R. TIMMONS, JR., in the State aforesaid,
