CHARTER
BY THE SECRETARY OF STATE

WHEREAS, GARY DRAKE, 416 Rutherford Road, Greenville, S. C.;
ROBERT L. HUDSON, 18 Endell Street, Greenville, S. C.;
J. WILBUR WALKER, 214 North Leach Street, Greenville, S. C.

did on the 5th day of October, 19 60, file with the Secretary of State a written Declaration,
signed by themselves, setting forth:

FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is
TEXTILE CITY BEAUTY AND BARBER SUPPLY COMPANY, INCORPORATED

THIRD: That the principal place of business is GREENVILLE, SOUTH CAROLINA

FOURTH: That the general nature of the business which it is proposed to do is to establish, maintain and manufacture, or job, distribute, wholesale, and retail, beauty and barbershop equipment, furniture and supplies, including the obtaining and acquiring by purchase, and otherwise manufacture or job any kind and all kinds of machinery, products and by-products thereof of every kind and description, and by whatever process the same can or may be produced, and generally to buy, sell, exchange, lease, acquire and deal in beauty parlor equipment, and to conduct all business appertaining thereto. To purchase or otherwise acquire and control franchises of products and equipment; to purchase or otherwise acquire, any and all letters patent, and similar rights in this State and other States of the United States; to purchase or otherwise acquire any inventions which may seem capable in being used for in connection of said purposes of said corporation, and to use, develop, sell and grant licenses for the same; and to distribute, wholesale, job, and retail stationery, cards, novelties of all kinds and nature.

FIFTH: That the amount of the capital stock is Five Thousand (\$5,000.00)----- Dollars payable in property and money

SIXTH: That the number of shares into which the capital stock is divided is Two Hundred (200) of the par value of Twenty-five (\$25.00)----- Dollars.

SEVENTH: That, after due notice, a meeting of the subscribers was held on the 13th day of August, 19 60, at which a majority of all stock in value being present in person or by proxy, the following were elected directors: Gary Drake, Robert L. Hudson, Nathaniel J. Brockman, J. Wilbur Walker

EIGHTH: That subsequently there was elected as President, Gary Drake ; as Vice-President, Nathaniel J. Brockman ; as Secretary, J. Wilbur Walker ; as Treasurer, Robert L. Hudson

NINTH: That all requirements of Title 12, Article 1, Chapter 2, Code of Laws of South Carolina, 1952, and all amendments thereto have been duly and fully complied with, 50 per cent. of the aggregate amount of the capital stock having been subscribed by bona fide subscribers, 20 per cent. of the capital stock subscribed having been paid to the Treasurer, and three days' public notice of the intention to file this Declaration with the Secretary of State having been given in the Greenville Piedmont a newspaper published in the County of Greenville

NOW, THEREFORE, I, O. FRANK THORNTON, Secretary of State, by virtue of the authority in me vested by the aforesaid Code and Acts amendatory thereto, do hereby certify that the said Company has been fully organized according to the laws of South Carolina, under the name and for the purposes indicated in their written declaration, and that they are fully authorized to commence business under their charter; and I do hereby direct that a copy of this certificate be filed and recorded in the office of the Register of Mesne Conveyance or Clerk of Court in each county where such Corporation shall have a business office.
