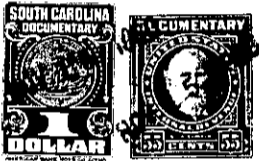
That T. A. Long and J. C. Davis in consideration of the sum of Two Hundred and no/100 in the State aforesaid, DOLLARS,

Charles E. Crumpton, his heirs and assigns fofever:

All of that lot of land in the County of Greenville, State of South Carolina, and being shown as a 20 foot strip on a plat of property of Clyde Dill recorded in the R.M.C. Office for Greenville County in plat book UU at page 85 and having, according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the western side of Cahu Drive, at the joint front corner of said 20 foot strip and lot 22, which iron pin is situate 285 feet in a southerly direction from the intersection of Cahu Drive and Ike's Road and running thence with Cahu Drive, S 1-30 W, 20 feet to corner of lot 21; thence with the line of lot no. 21, N 88-30 W, 215.6 feet to an iron pin; thence N 4-43 W, 20.1 feet to an iron pin; thence with the line of lot 22, S 88-30 E, 216.8 feet to the point of beginning.
