

and western margin of Caledonia Road in a southwesterly and southern direction to the northernmost point of Lot #1231; thence in a southerly direction with the western margin of Caledonia Loop and the eastern boundaries of Lots 1231, 1230, 1229 and 1228, to a corner of Lot #1227; thence in an easterly direction with the southern margin of Caledonia Loop and the northern boundaries of Lots 1227, 1219, 1218, 1205, 1204, 1203, 1202, 1201, 1200 and 1199, to the northeast corner of Lot 1198; thence with the eastern margin of Lot 1198 in a southeasterly direction to the northwest corner of Lot 1197; thence with the northwestern margin of Lot 1197, the western margin of Lots 1196 and 1195, and the southwest margin of Lot 1194, to the corner of Lots 1194 and 1193 in Caledonia Loop; thence with the southern boundary of Lot 1234 to a point on Caledonia Loop; thence in a north and northwesterly direction with the north and northeasterly margin of Caledonia Loop; and the south and southwesterly margin of Lots 1234, 1189, 1188, 1187, 1186 and 1232, to the southwest corner of Lot 1232; thence with the southwest margin of Lot 1232 in a northwesterly direction, 30 feet to the southern margin of Monans Rill Road; thence with the south margin of Monans Rill Road in a northeasterly direction to a point in said southern margin of said road, which would lie on the southern prolongation of the southern boundary of Lot 1233; thence in a northwesterly direction across Monans Rill Road and with the southern boundary of Lot 1233, to the place of beginning.
