G. Y. STYLES, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Bates Township, Greenville County, State of South Carolina, near Travelers Rest, and being known and designated as Lot Number 11 as shown on a revised map of Lots Numbers 34 through 47 of a subdivision known as Meadowbrook Farms, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book PP at Page 113, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southern side of Loraine Drive at the joint front corner of Lots 10 and 11 and running thence S 03-00 W approximately 154 feet to a point in a branch, said point being the joint rear corner of Lots 10 and 11; thence with said branch as a line approximately S 73-30 E approximately 102.8 feet to a point at the joint rear corner of Lots 11 and 12; thence N 03-00 E approximately 177 feet to a point on the Southern side of Loraine Drive at the joint front corner of Lots 11 and 12; thence with the Southern side of Loraine Drive N 87-00 W 100 feet to the point of beginning.
