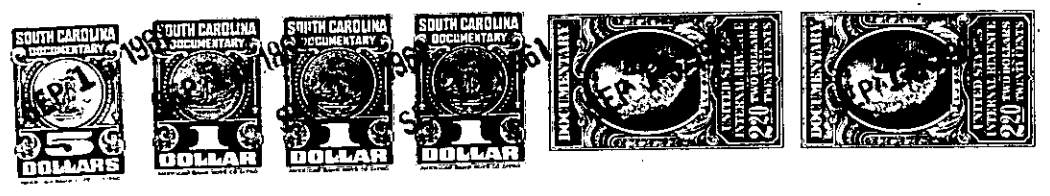
KNOW ALL MEN BY THESE PRESENTS That FIDELITY COMPANY, INC.

HART AND MARY H. HART:

All that piece, parcel or lot of land, with the improvements thereon, situate, lying and being in or near Greenville, in the County of Greenville, South Carolina, and being more particularly described as Lot No. 105 as shown on plat entitled Subdivision for Abney Mills, Poinsett Plant, Greenville, South Carolina, made by Pickell & Pickell, Engineers, March 5, 1959, and recorded in the R.M.C. Office for Greenville County in Plat Book QQ at page 51. According to said plat the within described lot is also known as No. 109 Gates Street and fronts thereon 48 feet.
