Powell lot, and runs thence with the Powell line, N. 85-00 E. 20 feet to an iron pin on the bank of the road, then continueing with the same course for a total distance of 436 feet to an iron pin on the Elsie Powell line; thence with the said line S. 14-00 E. 101.3 feet to an iron pin on the said line, new corner; thence S. 85-00 W. 448 feet to a nail and cap in the center of the Miller Road (iron pin back on line at 20 feet); thence with the said road, N. 6-15 W. 100.3 feet to the beginning corner, containing One and Two One-hundredths (1.02) acres, more or less.
