That I, J. Frank Williams

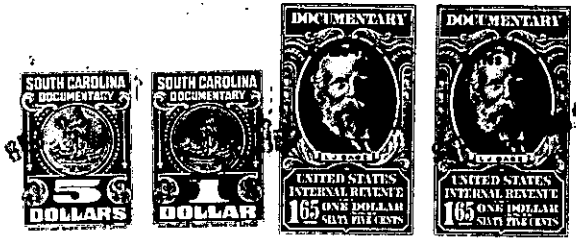
in consideration of the sum of Three Thousand and no/100 (\$3,000.00) in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said R. O. Nichols, his heirs and assigns, forever:

ALL those pieces, parcels or lots of land situate, lying and being in Greenville County, South Carolina, being shown as Lots Nos. 104 and 105 of Western Hills, Plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book QQ at Pages 98 and 99 and, according to said Plat, having the following metes and bounds, to-wit:

BEGINNING at a point on the south side of Alice Farr Drive at joint front corner of Lots Nos. 103 and 104, and running thence with the line of said lots, S. 16-30 E. 175.1 feet; thence N. 73-40 E. 200 feet; thence N. 16-30 W. 175.3 feet to a point on the south side of Alice Farr Drive; thence with Alice Farr Drive, S. 73-30 W. 200 feet to the point of beginning.

This conveyance is subject to the recorded restrictions applicable to Western Hills and to the set-back line and easements shown on said Plat.
