That I, J. Frank Williams

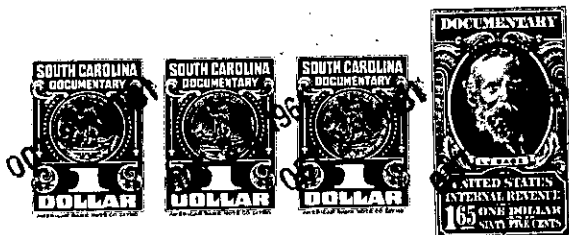
in consideration of the sum of Twelve Hundred Fifty and no/100----- in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Janie Harding, her heirs and assigns, forever:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, and being shown as Lot No. 148 of Western Hills, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book QQ, Pages 98-9, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Alice Farr Drive at joint front corner of Lots Nos. 147 and 148, and running thence with the line of said Lots, S. 23-30 W. 206.4 feet; thence N. 73-50 E. 133.7 feet; thence N. 31-56 E. 115.7 feet to an iron pin on Alice Farr Drive; thence with Alice Farr Drive, N. 61-19 W. 70 feet; thence continuing with Alice Farr Drive, N. 66-30 W. 50 feet to the point of beginning.

This conveyance is made subject to the easements and rights-of-way shown on said plat, and to the recorded restrictions applicable to Western Hills.
