Deed for South Carolina

KNOW ALL MEN BY THESE PRESENTS, NEAL J. HARDY of Washington successor in office to NORMAN P. MASON

D. C., as Federal Housing Commissioner / Grantor, for and in consideration of the sum of One Dollar (\$1.00) and other valuable considerations, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto

MILTON LOLLIS and DOLORES P. LOLLIS

Grantee(s), and to the heirs and assigns of said Grantee(s), ALL THAT CERTAIN piece, parcel or lot of land in the State of South Carolina, County of Greenville, on the Southern side of Echols Drive near the City of Greenville, being shown on a plat of property of Elizabeth E. Voyles recorded in Plat Book "Y" at page 73, said lot being known as Lot Number 25, and being described as follows:
