All that parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, near the City of Greenville, known and designated as Lot No. 9, Block "N" of a plat of Riverside, made by P. H. Foster, Surveyor, recorded in the RMC Office for Greenville County in Plat Book "A" at pages 322 and 323, and having the following courses and distances, to wit:
